Vsebina:

Obravnavana so izbrana poglavja iz naslednjih sklopov.

Gre za predmet, v okviru katerega je predstavljena problematika naravovarstvene zakonodaje in razumevanja le te. Gre za nauk o temeljih ekološkega prava in za spoznanja, kako uzakoniti zmernost in vzdržanje pri človekovih odnosih z živimi bitji in neživim svetom. Predstavljen bo antropocentrizem kot razlog za uničevanje živega in neživega sveta. Pri vprašanju, kako uzakoniti zmernost, bodo predstavljeni pravno-filozofski pogled in mednarodni politični temelji ekološkega prava. Dodan bo ustavnopravni temelj in nato ureditev na zakonodajni ravni ter primerjalna ureditev. Povezanost z varstvom okolja bo obravnavana predvsem pri horizontalnih ukrepih in pravilih: v prvi vrsti filozofsko etični pristop, načela varstva okolja, politika varstva okolja, instrumenti v pravu okolja itd., medtem ko bodo pri horizontalnih pravilih obravnavana tista, ki se ne nanašajo samo na določeno področje okolja (npr. voda, zrak, hrup, radiacija itd.), ampak so v uporabi iz različnih zornih kotov varstva okolja nasploh (npr. monitoring, dostop do informacij, presoja vplivov na okolje itd.). Pristop je interdisciplinaren. Gre tudi za analizo pravno-sistemskih določb o varstvu okolja in narave, ki imajo svojo osnovo tudi v ekonomskih razlogih, političnih in etičnih vidikih (ekocentrična etika) itd.

Contents (Syllabus outline):

Selected topics in the following chapters are discussed.

The teaching subject presents an issue of the biodiversity legislation and the proper understanding of such legislation. The topic taught is about basics of law of ecology. A question how to legalize principle of sustainable development in the relations among humans, biota and physical world. The anthropocentrism will be discussed as an approach responsible to a destruction of the world of biota and physical world. The question of sustainable attitude will be taught from philosophical and law aspect, together with the international political base of the ecology legislation. The constitutional and legislative level will be discussed, involving also comparative view. The link to the environmental law will be given mainly through horizontal measures and general rules: general rules cover philosophic-ethical issues, principles of environmental protection, politic of the environmental protection, instruments of the environmental law etc. By horizontal environmental legislation, legislation is meant which relates not only to a single sphere of the environment (water, air, noise, soil, radiation etc.) but which examines a given activity from a variety of environmental viewpoints. The approach is interdisciplinary. Legal analysis of the environmental legislation will base on economic, political and ethical (eco-centric ethic) point of views.

- Acquaintance with the upgraded principles of the environmental protection based on which the action of society can be assessed
- Advanced assessment of the role of the environmental legislation (based on a basic eco-centric approach)

- Podrobno uporabljati splošne institute varstva okolja in narave tudi na posameznih specifičnih področjih
