Evropska mreža uradov za integriteto raziskav (ENRIO) predstavlja glas raziskovalne neoporečnosti v Evropi. ENRIO je skupnost enako mislečih partnerskih organizacij in posameznikov, ki se zavzemajo za integriteto raziskav na nacionalni in evropski ravni.

V zadnjih 12 letih se je ENRIO iz majhne skupine vodilnih strokovnjakov razvil v enega ključnih akterjev, ki spodbujajo raziskovalno integriteto v Evropi. Mreža je uspešno oblikovala svoje poslanstvo, članstvo in dejavnosti, ki so primerljive z nekaterimi drugimi pomembnimi raziskovalnimi združenji v Evropi. Od ustanovitve leta 2008 se je mreža ENRIO hitro razvijala, saj ima danes že 31 članov, ki so razpršeni po 23 državah. Rast članstva je povečala vpliv in učinek mreže. Leta 2020 je ENRIO postal pravna oseba, kar je omogočilo oblikovanje učinkovite dolgoročne strategije za prihodnost mreže in za izboljšanje raziskovalne integritete v Evropi. Over the last 12 years, ENRIO has grown from a small group of leading professionals into one of the key players that are advancing research integrity in Europe. The network has successfully built a mission, membership and activities that are comparable to some of the other key research associations in Europe. Since the network's inception in 2008, ENRIO has rapidly enlarged its membership. Today, the network has 31 members who are spread across 23 countries. This membership development has increased the influence and impact of the network. In 2020 ENRIO became a legal established association enabling it to create an effective long-term strategy for the future of the network, and for the advancement of research
